We have 6 individuals who have requested PHB to date, 2 of which have been completed.

4. What percentage of people who requested a personal health budget in that time were accepted?	There are 2 individuals who have completed and in receipt of a PHB and an additional 4 who are in different stages of the process. 100% who have requested a PHB have been accepted

All individuals who meet the eligibility criteria under CHC and or CC are notified or the right to have a PHB via the CHC team and or the community nursing teams

There is a process in place for stakeholder engagement which is being supported by 3rd sector e.g. Sefton CVS and Sefton Carers Centre. The CCG is currently developing the 'local offer' which is required to be published on the CCG website from April 2016, to provide advice and guidance.</p>
