**Re: Freedom of Information Request**

Please find below the response to your recent Freedom of Information request regarding fertility treatments and plans within NHS Southport and Formby CCG.

Request/[Response](#):

I write to request the following information on your Clinical Commissioning Group's current fertility treatments and plans.

The revised 2013 NICE guidelines recommend that 3 cycles of IVF treatment should be provided for couples where the female partner is aged under 39, has an identified cause of infertility or infertility of two years duration.

Women aged 40-42 years who have not conceived after two years of regular unprotected intercourse or 12 cycles of artificial insemination, should be offered one full cycle of IVF

3. What is your estimated funding gap for the years [2015/16](#) [2016/17](#) 2017/18 and 2019/20?

NHS Southport and Formby CCGs funding gap is the difference between the funding allocation and the expenditure commitments in each financial year. The table below outlines the CCG's current financial plan. Note that 2016/17 figures are draft and subject to final confirmation of the CCG year end position.

4. Is the funding gap affecting your ability to fund fertility treatments? And more broadly, do you think IVF provision by the NHS is unsustainable in light of funding pressures?

NHS Southport and Formby CCG continues to review all our commissioned services in light of financial pressures.

5. Have you held a public consultation on IVF provision in your local area? If you have held a consultation can you provide the details of the questions you asked and the decision you made in regard to services?

The last consultation was held in 2014 and was part of the review of the commissioning policy as a result of this we commissioned services in line with NICE guidance.

6. If you answered no to question 5, do you have any plans to hold a public consultation on IVF provision? If so, can you detail the proposed scope of that consultation and the options you will offer the local community in regards to service?

NHS Southport and Formby CCG will be reviewing the policy this year as part of our wider review of the commissioning policy but are unable to give details at this point as this phase of the review hasn't commenced.

7. If you answered no to question 6 will you rule out running a consultation in 2017/18, 2018/19 and/or 2019/20

NHS Southport and Formby CCG are reviewing our commissioning policy of which the fertility policy is part of this. This will involve a consultation however until the policy has been reviewed we are unable to comment on the content of the consultation.
