In accordance with the Freedom of Information Act 2000, I would be very grateful if you could please send details for:

- 1) All in-patient and out-patient eating disorder services currently provided for CAMHS and adult services in your area

NHS Southport and Formby CCG commission Alder Hey (in partnership with Liverpool CCG) to deliver a Specialist Community Eating Disorder Service for young people up to 18. In addition our local CAMHS provider (Alder hey) does support young people with less severe eating disorders.

NHS Southport and Formby CCG does not commission adult in-patient eating disorder services, this service is commissioned by Specialised Commissioning, NHS England. NHS Southport and Formby CCG commissions Mersey Care NHS Trust to commission the service for out-patients.
