Request/Response:

 Are you partnering with any other private or public sector organisations to deliver your Personal Health Budgets (PHBs)? If so, please provide the names of those organisations and a summary of the services they provide to the CCG

The CCGS works in partnership with a number of independent and public organisations to deliver PHB's. This includes:

- NHS community and mental health providers to support the development of the care plan in line with individual needs
- A variety of independent PHB support providers; InStream, Salvere, Health Your Way and Sefton Carers Centre including Sefton Advocacy. To support an informed decision on type of PHB and developing the support plan to meet the needs inline with the clinical care plan.
- Midlands and Lancashire Commissioning Support Unit, who sign off on the support plan, indicative budget and reviews in line with required timeframes.
- Sefton Carers Centre provide the payment scheme via means of a payment card and financial auditing for those who have a PHB with them
