## **Re: Freedom of Information Request**

Please find below the response to your recent Freedom of Information request regarding IVF for female same-sex couples within NHS Southport and Formby CCG.

## Request/Response:

- 1. Please disclose:
  - a. Whether or not Southport and Formby CCG funds IVF services for female same-sex couples?

This policy is intended, as per NICE guidance, for people who have a possible pathological problem (physical or psychological) to explain their subfertility. The CCG will fund subfertility treatment for same sex couples and single women provided there is evidence of proven subfertility.

b. If so, how many cycles of IVF per couple does the CCG fund per couple?

At present, 3 cycles of IVF will be funded as long as the criteria is met.

- 2. If the answer to (1a) is yes, please disclose:
  - a. Under Southport and Formby CCG's current policy, how many cycles of artificial insemination must be undertaken by a female same-sex couple in order to become eligible to access NHS-funded IVF?

Subfertility is defined as no live birth following artificial insemination (AI) of up to 6 cycles or proven by clinical investigation as per NICE guidance. AI must be undertaken in a clinical setting with an initial clinical assessment and appropriate investigations.

b. How many of the abovementioned cycles of artificial insemination must be self-funded by the couple?

The CCG will not fund the AI cycles referred to but will fund access to a clinical consultation to discuss options for attempting conception, further assessment and appropriate treatment.
